## **Planning for Nov. 12-13 Diocesan Convention gets underway**

The 2021 Diocesan Convention will take place *Friday-Saturday, Nov. 12-13*. If COVID-19 metrics allow for an in-person gathering, the convention will be held at the DoubleTree Hotel in Danvers. Highlights include:

- Friday afternoon and evening programs open to all
  - Friday afternoon workshop series with both plenary and small-group opportunities
  - Convention Eucharist with guest preacher Bishop Douglas J. Fisher of the Diocese of Western Massachusetts
  - Friday evening keynote address, guest speaker TBA
- Saturday business sessions developed primarily for voting members of the convention;
- Structured to enable a pivot to virtual format should COVID-19 preclude in-person gathering.

Friday afternoon and evening programming will offer opportunity for education and spiritual formation around a central theme. Development of the theme and associated programming is underway, and specifics will be announced soon. A determination will be made in late summer as to whether the convention will be held in-person at the DoubleTree Hotel or virtually on Zoom, dependent on COVID-19 metrics at that time. However, the above programmatic highlights will be offered whether convention is in-person or virtual. Everyone is invited to mark their calendars and spread the word. *FOR INFORMATION: The Rev. ***Limited immigration  
legal services now  
available***

Diocesan mission strategy makes a commitment to invest in ministry with immigrants and communities of color. Some members of this population are at different stages in their immigration processes, and for many of them, aspects of the related legal processes may be unaffordable. To respond to this pressing situation, the Rev. Canon Dr. Jean Baptiste Ntagengwa, Canon for Immigration and Multicultural Ministries, has completed the process for recognition by the U.S. Department of Justice to offer some limited legal services to individuals who meet certain guidelines, according to a suggested fee schedule and with fee waiver available to those

who qualify. He now can offer, among other services: initial consultation, representation at USCIS interviews, help with address changes, DACA renewal, religious worker petitions, non-immigrant religious visas, status adjustments, Temporary Protected Status (TPS), naturalization applications and citizenship certificates. ## **GRANTS & LOANS:**

- **Mission Strategy "Wicked Good Idea" Microgrants:** The Mission Strategy Committee of Diocesan Council is receiving applications for "Wicked Good Idea" microgrants to help congregations, networks or diocesan organizations try out a great idea that's meant to further our shared [mission strategy](#).

In 2021, a total of \$15,000 is set aside for individual grants from \$500 to \$2,000. There is no application deadline; applications are received and grants awarded on a rolling basis until the funds are gone. Unlike during 2020, this year's grants will not fund technology for livestreaming services. Applicant congregations need to be in compliance with diocesan guidelines to receive a grant. At its March 18 meeting, the Diocesan Council:

Heard an update about the Racial Justice Commission.

Heard a report from the Treasurer's Office about the draft 2022 assessment formula.

Heard a report from the St. John St. James Church, Roxbury Executive Committee about the restoration of the property.

Voted to withdraw up to \$888,588 from invested funds for the following purposes: the additional costs of the renovation of St. Mark's rectory, Dorchester; phases II and III of the renovation of St. Luke's Chapel at St. John St. James Church, Roxbury; the additional costs of phase I of the renovation of St. Luke's Chapel, Roxbury; and an existing conditions survey of the former Church of St. Luke and St. Margaret, Allston. The withdrawal will be replaced from the proceeds of the sale of 40 Prescott Street in Brookline.

Voted to withdraw up to \$289,607 from invested funds for the maintenance, art preservation and emergency roof and retaining wall repairs to the property of St. John St. James Church, Roxbury.
