Standing with Families from Puerto Rico Displaced by Hurricane Maria as They Fight for Permanent Housing Ahead of Final FEMA Deadline of June 30th

WHAT WE'RE FACING: Thousands of displaced people from Puerto Rico are facing homelessness after June 30th, the final FEMA/Red Cross deadline for the Transitional Housing Assistance (TSA) program, which has been paying for hotel rooms for these families after Maria (September 20th, 2017). Some of these families have been living in hotels for over seven months. These families have nothing to return to on the island and no clear path to permanent housing here on the mainland. The federal government can help. There is a program called the Disaster Housing Assistance program (DHAP) that has been used following natural disasters in the past (Katrina, Rita, Gustav, Ike and Sandy). This program was designed to address the medium and longer-term housing needs of survivors of natural disasters. The program provides subsidies to help families pay rent, security deposits and utility payments. DHAP functions with an interagency agreement between the Department of Housing and Urban Development (HUD) and FEMA. No Congressional action is needed to activate DHAP. HUD is ready to activate DHAP but FEMA has rejected requests to activate DHAP, including a request by Governor Rossello of Puerto Rico. Thousands of Americans from Puerto Rico will become homeless at the end of this month because of FEMA's inaction. This is unacceptable.

Members of Congress are now acting to activate DHAP through legislation. Senator Bill Nelson (FL) has introduced a bill and now Elizabeth Warren (MA) and Ed Markey (MA) have introduced a bill calling for the immediate activation of DHAP to address the urgent needs families are facing currently. Included are attachments about the Nelson and Warren/Markey bills in both English and Spanish.

WHAT WE ARE DOING NOW: Pioneer Valley Project, a grassroots community organization in Springfield, MA has been organizing displaced families in Western Massachusetts (the Springfield/Holyoke area has seen the highest proportion of evacuees in the state) still stuck in hotels for the last several months and the families have been pressuring Senators Elizabeth Warren and Ed Markey to act to prevent them from becoming homeless. Now that Warren and Markey have reacted by introducing legislation, approximately 100 people from the displaced families in Western Massachusetts are heading to Washington D.C. to share their stories with Congressional offices and push for immediate legislative action. The families will board buses Wednesday morning (June 6th) and return to Massachusetts on Thursday evening (June 7th).

ASKS OF INFLUENCERS:
