Standing Committee Official Acts September 2009 through June 2010

A note from the co-secretary of the Standing Committee:

The official acts listed below provide just a glimpse of the work of the Standing Committee of the Diocese of Massachusetts. The Standing Committee serves as the bishops' advisory committee as well as fulfilling canonical roles of providing advice and consent on issues relating to congregational by-laws, real estate alienation and encumbrance, and the ordination of persons as deacons, priests, or bishops. The Standing Committee provides advice concerning personnel conflicts, either within congregations or within the diocese.

The Standing Committee meets monthly from September through June for three hours. The first half of the meeting is devoted to providing advice to the bishops and senior staff. The second portion focuses on canonical responsibilities.

The most noteworthy trend during the 2009-2010 term has been the vast expansion in requests for consent on real estate related issues, including the sales of closed congregations, the redevelopment of excess property by existing congregations, and ongoing maintenance financed through loans. To meet the increased demand, the Standing Committee established a Real Estate Advisory Committee to assist its review of the many requests. The REAC will be publishing a new set of Policies and Guidelines for the Alienation or Encumbrance of Real Estate by late 2010. The Standing Committee wishes to express its profound gratitude to Jeff Brown, Alice Krapf, Chris Meyer, and James Wagner for the countless hours donated to help the diocese in their stewardship of real estate.

The lease must also be approved by the Standing Committee.
- 4. VOTED to give approval for St. Peter's. Buzzards Bay to negotiate documents with S42 Development Associates for development of a 21-unit mixed-income housing project, subject to several conditions.
- 5. VOTED to recommend the Rev. Matthew Kruger for ordination to the priesthood.
- 6. VOTED to consent to the ordination of Brian Norman Prior as Bishop Diocesan of the Diocese of Minnesota.
